**APPOINTING DAVID DICKSON

WHEREAS, a vacancy in Zone 1 has been created on the Board of Directors by reason of the resignation of Glenn Reynolds;

WHEREAS, Section 30504 of the California Water Code and Section 1780 of the California Government Code authorize the Board of Directors to fill by appointment a vacancy occurring on the Board of Directors;

WHEREAS, on March 2, 2026, the Board took action to begin the process of filling the vacancy through an appointment process;

WHEREAS, the District notified the County elections officer, and posted a Notice of Vacancy in three conspicuous places within the District boundaries seeking statements of interest and qualifications from interested and eligible members of the public to fill the Zone 1 Board vacancy;

WHEREAS, the District initially received two statements of interest, however one person withdrew their statement of interest, leaving only one candidate to consider to fill the Board vacancy; and

WHEREAS, the Board evaluated the one remaining candidate who submitted a statement of interest for the Board vacancy; and

WHEREAS, the Board of Directors has complied with all of the applicable statutory procedures for filling the vacancy on the Board by appointment.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Coastsides County Water District hereby appoints David Dickson to serve as a member of the Board of Directors of the Coastsides County Water District to fill the Zone 1 vacancy created by the resignation of Glenn Reynolds.
