**Background**

Coastside County Water District entered into a contract with Andreini Bros., Inc. on August 14, 2024, for the Nunes Treatment Plant Paving Project.

The work consisted of paving approximately 18,270 sf of roadway and pavement, installation of approximately 275 LF of 4-inch Ductile Iron Pipe by open trench and installation of approximately 310 LF of four 1-inch conduits.

The site of the work is located at the Nunes Water Treatment Plant, located at 500 Lewis Foster Drive, in the unincorporated community of Half Moon Bay, California in San Mateo County (Assessor Parcel Number 056-320-090).

The work was completed on October 26, 2024, in accordance with District specifications.
