

NOTICE TO CONTRACTORS

NOTICE IS HEREBY GIVEN that sealed bids will be received until the hour of 10:00 a.m. local time, on Tuesday, December 17th, 2024, at the office of the Coastside County Water District, 766 Main Street, Half Moon Bay, California 94019, for the Highway 92 Emergency Pipeline Replacement Project. Bids can be delivered by mail, FedEx, or other delivery service, or dropped off at the District's office. If mail or delivery service is chosen, the contractor acknowledges that the Bid may not arrive by the Bid Open date and time. Bids will be opened publicly and read aloud immediately after they are due over teleconference. A teleconference link and call-in information are provided below:

This Public Works Contract consists of construction of Owner's Highway 92 Emergency Pipeline Replacement Project located on private property along Highway 92 in unincorporated San Mateo County. Work includes, without limitation:

1. Highway 92 Potable Water Pipeline Project - Phase 1 (Sta. 10+00 to Sta. 44+82, Sta. 70+00 to Sta. 73+00, and Sta. 80+00 to Sta. 83+40):
 - a. Installation of approximately 3,170 linear feet (LF) of 10-inch and 6-inch ductile iron pipe (DIP) by open trench construction within easements on private property along Highway 92, as shown on the Contract Drawings.
 - b. Installation of approximately 390 LF of High-Density Polyethylene (HDPE) water main by Horizontal

- Directional Drilling (HDD) within easements on private property along Highway 92, as shown on the Contract Drawings.
- c. Installation of water service lines and reconnection of water services.
 - d. Installation of three fire hydrant assembly.
 - e. Installation of valves and other appurtenances.
 - f. Abandonment of existing water facilities.
 - g. Connection of the new water main to the existing 12-inch Welded Steel (WS) and existing 8-inch ductile iron (DI) water lines.
 - h. Surface restoration.
2. Highway 92 Potable Water Pipeline Project - Emergency Restoration Phase (Sta. 44+82 to Sta. 65+15)
- a. Installation of approximately 1,000 LF of 10-inch DIP by open trench construction within easements on private property along Highway 92, as shown on the Contract Drawings.
 - b. Installation of approximately 1090 LF of HDPE water main by HDD within easements on private property along Highway 92, as shown on the Contract Drawings.
 - c. Installation of 2-inch copper tubing within a 4-inch steel casing pipe with pipe supports to attach to an existing bridge, as shown in the contract drawings.
 - d. Installation of water service lines and reconnection of water services.
 - e. Installation of three fire hydrant assembly.
 - f. Installation of valves and other appurtenances.
 - g. Removal of temporary bypass and site restoration
 - h. Abandonment of existing water facilities.
 - i. Connection of the new water main to the existing 12-inch Welded Steel (WS) water line.
 - j. Surface restoration.

A **mandatory Prebid meeting** will be held on Tuesday, November 19th, 2024, at 10 a.m. local time starting at the at the office of the Coastside County Water District, 766 Main Street, Half Moon Bay, California 94019. Representatives of the District will be available to answer questions and a project site visit will follow the meeting. Only bids from Contractor with representatives in attendance at the Prebid meeting will be accepted by the owner - all other bids shall be returned unopened.

The Engineer's estimate of the construction cost is \$2,651,000.

Print or digital requests/orders can be placed by the bidders emailing plans@barkerblue.com. A non-refundable fee of \$118.12 per set plus tax is required if picked up, or \$35 for electronic download. Barker Blue requires a minimum of four hours advanced notice for sets being picked up. Additional charges will apply as determined by Barker Blue for mailing and delivering bid sets. All arrangements for obtaining bid sets shall be made directly with Barker Blue and made payable to Barker Blue. Barker Blue will also be keeping the latest plan holder's list during the bid process. All bids must be on the prescribed forms.

Each bid must be enclosed in a sealed envelope addressed to the Board of Directors of the Coastside County Water District and marked on the outside:

"Bid for the Highway 92 Emergency Pipeline Replacement Project, Coastside County Water District Half Moon Bay, CA"

Each bid must be accompanied by a certified or cashier's check or by a corporate surety bond on the form furnished by the District as a guaranty that the bidder, will, if an award is made to him in accordance with the terms of his bid, promptly secure worker's compensation and employer's liability insurance, public liability insurance, and execute a contract in the required form; and furnish satisfactory performance and payment bonds. Said check or bidder's bond shall be in an amount not less than 10 percent of the amount of his bid. Pursuant to Public Contract Code Section 22300, the successful bidder shall be entitled to submit securities in lieu of the retention of progress payments (See Section G9.09 of these General Conditions of these Contract Documents).

Bidders and their proposed subcontractors shall hold such licenses as may be required by the laws of the State of California for the performance of the work specified in the Contract Documents. Bidders bidding as the prime Contractor shall possess a valid California Contractor's "A" License at the time of Contract award, and additionally shall meet the requirements contained in the Contract Documents. The Bidder must have been in business under its current business name for a minimum of two (2) years and have through itself or its key personnel a minimum of five (5) years of relevant work experience and completed at least three (3) construction projects for public agencies of a similar nature and complexity within the past five (5) years. The HDD Contractor and its key personnel shall also meet the experience requirements contained in the Contract Documents.

The District reserves the right at its sole discretion after opening bids to waive any and all irregularities in any bid, and to make award to the lowest responsible bidder, and to reject any and all bids.

This is a Public Works Contract. The attention of bidders is directed to the applicable federal and state requirements and conditions of employment to be observed and minimum wage rates to be paid under the Contract. Pursuant to Section 1773 of the Labor Code, the Department of Industrial Relations has established prevailing rates of per diem wages and general prevailing rates for holiday and overtime work in the locality in which the work called for by this Contract is to be performed for each craft, classification, or type of worker needed to execute this Contract.
